Request:

I'd like a copy of the minutes from todays meeting of the NIPB 31/08/2023.

#### Answer:

We can confirm that the Northern Ireland Policing Board holds information relevant to that which you have requested. However, we are withholding that information at this time since the exemption under section 22 of the FOIA (Information intended for future publication) applies to it.

A draft of the minutes has yet to be prepared by Board officials as such the finalised version of the minutes of this meeting is not yet available. Once the draft minutes become available they need to be ratified by the Board before they become 'final'. The minutes will then be published on the Board's website.

The section 22 exemption is a qualified exemption and is subject to consideration of a public interest test. This means that a public authority must determine whether, on balance, it considers it to be in the wider public interest to maintain the exemption, or to release the requested information. We have carried out a public interest test, (attached) and we are satisfied that in all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.

# Arguments that weigh in favour of disclosure

Release of the information would promote transparency, accountability and participation.

Providing the requested information is in line with the spirit of openness and transparency enshrined within FOI legislation.

### Arguments that weigh in favour of maintenance of the exemption

A draft of the minutes has yet to be prepared by Board officials and as such the finalised version of the minutes of this meeting is not yet available.

Once prepare the draft minutes have to be shared with the 3<sup>rd</sup> party who attended the meeting for comment on their input at the meeting. The 3<sup>rd</sup> party may recommend the information contained in the draft be amended.

Following consultation with the 3<sup>rd</sup> party, draft minutes of the meeting will be presented to the Policing Board for the consideration of Members. Subject to their approval the minutes will become 'final' and will then be published on the Board's website.

It is the intention of the Board to publish the minutes as soon as reasonably possible.

The Board should not place information in the public domain that may be inaccurate and subject to future amendment.

#### **Decision**

In all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.
